In a unique partnership with the Southern Illinois University School of Medicine and its innovative Breast Center, Y-ME Illinois is now offering support to breast cancer patients and survivors in the Springfield area via the



newly opened Y-ME Illinois Wig and Prosthesis Salon. Breast cancer patients can go directly from the

Breast Center patient rooms to our salon, where they receive, free of charge, wigs, hats, scarves, breast prostheses, and bras, as well as information about the other services offered by Y-ME Illinois. The salon had its grand opening celebration on April 5, 2006. The grand opening was attended by

First Lady Patti Blagojevich and included a spa night that offered complimentary massage therapy to patients along with free food, drinks and musical entertainment. The SIU Breast Center and Y-ME Illinois will move into a wonderful new space at the SimmonsCooper Cancer Institute in late 2007.

The Wig and Prosthesis Salon is just the latest of Y-ME Illinois services to be offered in Central Illinois. In Springfield and its surrounding area, there are two Open Door Support Groups, educational opportunities through the Springfield Urban League and advocacy programs at the State Legislature.

In order to spread the word about our ever expanding list of services, Y-ME Illinois had a booth at the 2006 Illinois State Fair as part of the First Lady of Illinois' tent, where the theme was women's health. This opportunity allowed us to reach out to the nearly one million visitors at the Fair.

Illinois Breast and Cervical Cancer Program Expanded

Y-ME recommends that women 40 or older get a mammogram every year. Yet, for women without health insurance, that's not easy. Fortunately, Governor Blagojevich recently announced an expansion of the Illinois Breast and Cervical Cancer Program (IBCCP) – the state's program that helps women get access to screening and treatment. The new plan expands the income threshold, enabling thousands more women to get free cancer screenings and treatment. Women who earn up to \$50,000/year in a family of four will now be eligible. And for women who get screened outside of IBCCP and find out they have cancer, the program has been expanded to ensure access to the treatment they need.

Kate Chandler



"Anyone who has taken on the rigors of preparing for and running a 26.2 mile marathon can vouch for the grit required to see it through. A 62-mile ultramarathon, on the other hand, is an entirely different animal..." wrote Gary Seymour, Herald-News writer. Kate Chandler's mother, Jackie, a champion runner, ran both of these a

week apart in 1984. She completed dozens of marathons including the prestigious Boston Marathon.

When Kate was in 6th grade, her mom was diagnosed with breast cancer, and less than two short years later passed away. Throughout those years, the one thing her mom continued to pour her heart into was running. Neither the weather nor the chemotherapy could slow her down. She thought the sooner she got the chemo out of her system, by running and sweating, the sooner she would feel better. She always encouraged Kate to join her on her runs and even signed Kate up for cross-country and track in middle school.

Last year, while running the Chicago Half Marathon, Kate met a woman wearing a Pink Streak Singlet and asked her where she got it. The woman explained that she was running with the Y-ME Illinois Pink Streak Team. Right then and there, Kate knew she wanted to run the 2006 LaSalle Bank Chicago Marathon with Pink Steak in honor of her mom, Jackie Chandler. Kate has decided to take on this amazing challenge, knowing that her efforts will help to ensure that no one faces breast cancer alone and is a proud Pink Streak runner.

Kate has said that her mom is her inspiration, that she hopes to carry on her tradition, and every time Kate puts on her running shoes and with every step that she takes, she thinks back to all those mornings when she would join her mom on her runs. As Kate prepares to run The LaSalle Bank Chicago Marathon for Y-ME Illinois, she knows that her mom is running by her side.

Genetic Testing: Things to Consider

Breast cancer survivors often consider genetic testing to help establish hereditary cancer risk for their loved ones. Yet, many are concerned about possible risks of genetic testing. Individuals must assess the benefits and risks of genetic testing; knowing that genetic privacy is partially protected by national and state laws but there are loopholes in these existing protections. Meeting with a genetic counselor to learn about hereditary cancer and its medical impact for you and your relatives is a good first step when considering testing and is essentially risk-free. Be sure to ask the genetic counselor what control you will have over the flow of information and who can view your records.

Most breast cancer is not caused by known hereditary factors but women who do carry BRCA1 or BRCA2 mutations may need heightened breast cancer screening such as

MRI, and should learn about chemoprevention and surgical prevention. Mutation carriers who have completed child-bearing are generally recommended to have preventive ovarian surgery, since there are no reliable screening methods or early warning signs for ovarian cancer. Relatives who test negative for a known familial mutation are reassured and know they cannot pass on the tendency to their children. If your personal and family history fits a hereditary pattern, you may be a better candidate for genetic testing as a survivor than your unaffected relatives. The potential risks of genetic testing are thought to be smaller for people who have already had cancer because discrimination is more likely to occur on the basis of actual disease (e.g. breast cancer) than on the basis of disease predisposition (e.g. a positive gene test).

To date thousands of individuals in the U.S. have had gene testing for hereditary cancer. Henry T. Greely, JD, writing for the New England Journal of Medicine, found few examples of genetic discrimination for predisposition to disease, and no evidence that it is common. National genetic legislation is in place via the Health Insurance Portability and Accountability Act of 1996 (HIPAA), the Americans with Disabilities Act, the Employee Retirement Income Security Act, and Executive Order 13145 which protects federal employees. HIPAA protects people in large group plans from being dropped from coverage, or having their individual rates raised based on genetic test results. Note that HIPAA does not prohibit the use of genetic information as a basis for increasing the rate of group coverage; nor does it limit the collection of genetic information, requiring an individual to take a genetic test, or the disclosure

of genetic information by insurers. HIPAA does prevent coverage from being determined on the basis of a person's health and from considering genetic risks as preexisting conditions, except by small group plans and the smallest businesses. This leaves people who purchase their own underwritten coverage, or have coverage from very small employers, at risk. However, these groups can be protected by state laws.

Illinois has genetic privacy laws and state law prohibits health insurers and managed care plans from seeking genetic test results or using those results for non-therapeutic purposes, even if insurers provided coverage for the genetic testing. Illinois law also prohibits genetic discrimination in hiring, firing, and/or terms, conditions or privileges of employment. However, there are some gaps in Illinois law in regards to employment protections. To view detailed policy and legislation on genetic discrimination, visit www. genome.gov/PolicyEthics/ and follow links to the policy database.

Fear of genetic discrimination can prevent people from seeking potentially lifesaving genetic information which could be important for themselves and their relatives. Current legal protections are comprised of a complicated web of federal and state laws, most of which have never been tested in the courts. Additionally, no states in this region prohibit the use of genetic information for life, disability, or long-term care insurance. The U.S. Senate passed the "Genetic Information Non-Discrimination Act of 2005" (S.306), by a vote of 98-0 in February 2005 but its companion bill, H.R. 1227, has not yet been acted upon. Broad federal legislation regarding genetic discrimination would help erase any doubts left by the patchwork of existing laws and now is the time to register your opinion with your U.S. Representatives.
