

**NORTHSHORE UNIVERSITY HEALTHSYSTEM CELEBRATE HEALTH  
EMPLOYEE CONTEST OFFICIAL RULES**

1. **CONTEST PERIOD:** CONTEST begins on 12 a.m. Central Time ("CT") on October 1, 2015 and ends at 11:59 p.m. Central Time on October 31, 2015 ("Entry Period").
