NorthShore University HealthSystem "VAX2WIN" Raffle OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

- 1. <u>Eligibility</u>. The NorthShore University HealthSystem "VAX2WIN" Raffle (the "Promotion") is open to current employees, up to the Manager level, of NorthShore University HealthSystem including its wholly owned affiliated subsidiaries ("NorthShore") and contingent worker team members of NorthShore, who have been vaccinated for COVID-19, including those who commence a vaccine series within the Entry Period ("participant(s)"), with complete vaccination to be verified and determined at NorthShore's sole discretion prior to awarding a prize. Physicians are ineligible to participate. Eligible entrants must be 18 years of age or older or the age of majority in their state, whichever is older, at the time they enter. NorthShore reserves the right to determine whether any local laws, regulations other rules of the jurisdiction where a potential winner resides permit the awarding of the prize under these rules without what NorthShore in its sole discretion believes to be a detrimental effect upon the organization. Based on NorthShore's determination of this effect, it may deny making an award to such potential winner without notice and thereafter award the prize in question to another eligible person selected through random drawing from remaining eligible entries.
- 2. <u>Sponsor</u>. NorthShore University HealthSystem is an Illinois not-for-profit corporation, with its registered office at 1301 Central Street, Evanston, Illinois 60201 ("Sponsor").
- 3. <u>Agreement to Official Rules</u>. Participation in the Promotion constitutes Participant's full and unconditional agreement to these official rules and the decisions of Sponsor, which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein in a timely manner.
- 4. <u>Entry Period.</u> The Promotion begins on July 20, 2021 at 12:00 a.m. Central Time ("CT") and ends on September 1, 2021 at 11:59 p.m. CT (the "entry period"). Entries received prior to or after the entry period will be disqualified.
- 5. <u>Entry</u>. To enter, during the entry period, you must visit <u>www.northshore.org/vax2win</u> to complete and submit the requested fields of information ("Entry Form"). Once Participant submits the Entry Form, Participant will receive one (1) entry into the Promotion. Any entries attempted through the use of agencies or robotic, repetitive, automatic, programmed or similar methods will be void. Entries will not be acknowledged or returned.
- 6. <u>Drawing</u>. Throughout the entry period, Sponsor will select potential winners in a random drawing of accumulated entries each Thursday, with the planned final drawing of three potential winners on Thursday September 2, 2021. Odds of winning depend on the number of eligible entries received and location (e.g. legacy NorthShore, legacy Swedish Hospital, or legacy NCH) of Participant. Sponsor will verify eligibility of all potential winners and attempt to notify potential winner by phone, email or in-person, and potential winner must respond within 3 days of the date contacted by Sponsor or may result in a forfeiture of the prize and selection of additional potential winners. Winners will be publically announced.
- 7. Requirements of Potential Winners. Except where prohibited, a potential winner must complete and return an affidavit of eligibility and liability/publicity release (the "affidavit/release"). If a potential winner fails to sign and return the affidavit/release within the required time period, if notification or prize is returned as undeliverable, if Sponsor determines in its sole discretion that the potential winner is ineligible, and/or if a potential winner fails to respond to initial notification attempt in a timely fashion, he or she will forfeit the prize and an alternate entrant may be selected in his or her place by random drawing from among remaining eligible entries (time permitting). Unless prohibited by law, acceptance of a prize constitutes permission for Sponsor to use winner's name, picture, likeness, address (city and state), and biographical information for advertising and publicity purposes without further compensation.
- 8. <u>Prizes.</u> Once Sponsor has determined that Participant(s) are fully eligible to win the Promotion, Participant(s) will be deemed a winner. Fifteen (15) winner(s) will receive a cash prize. Twelve (12) prizes will be in the amount of \$500 U.S. Dollars and Three (3) grand prizes will be in the amount of \$5000 U.S. Dollars. All prize specifications to be determined at Sponsor's sole discretion without guarantees. The approximate retail value ("ARV") of all prizes is up to \$21,000 U.S. Dollars. If the actual value is less than the stated ARV, difference in prize value will not be awarded. Additional terms and conditions may apply. Terms will be provided at the time

the prize is awarded. Any prize details that are not specified above will be determined by Sponsor, in its sole discretion. A prize may not be transferred and must be accepted as awarded. Winner may not request a substitute prize; however, the Sponsor reserves the right to substitute a prize (or component thereof) with another prize (or component thereof) of equal or greater value if the prize is not available for any reason, as determined by Sponsor in its sole discretion. All Prizes are a one-time offer and in no way entitles recipient to future NorthShore compensation, awards, or any other entitlement. The value of the prize may be subject to income tax which Sponsor will cover through a gross-up for active employees of NorthShore based on the ARV and the winner's tax reporting obligations, but which all other winners will be solely responsible for paying any tax obligations.

- 9. General Conditions. In the event that the operation, security or administration of the Promotion is impaired in any way for any reason, Sponsor may, in its sole discretion, suspend, modify and/or cancel the Promotion. If Sponsor terminates the Promotion, Sponsor may choose prize winners in a random drawing from among eligible, non-suspect entries received as of the termination and will provide notice of its action on Pulse. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the operation of the Promotion or to be acting in violation of these official rules or in a disruptive manner. Any attempt by any person to undermine the operation of the Promotion may be a violation of criminal and civil law, and, should such an attempt be made, the sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. If a dispute arises regarding compliance with these official rules, sponsor may consider, in its sole discretion, data reasonably available to sponsor through information technology systems in Sponsor's control, but Sponsor will not be obligated to consider any data or other information collected from any other source. Sponsor's failure to enforce any term of these official rules will not constitute a waiver of that or any other provision. In the event of a dispute as to any online entry, the authorized account holder of the email address used to enter will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online-service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. In the event that an entry is confirmed to have been erroneously deleted, lost or destroyed, entrant's sole remedy shall be another entry into the Promotion. If any provision of these official rules is held to be invalid or unenforceable, such provision shall be struck, and the remaining provisions shall be enforced.
- 10. Release and Limitation of Liability. By participating in the Promotion, Participant agrees to release and hold harmless Sponsor and all prize providers from and against any claim or cause of action arising out of participation in the Promotion or receipt or use of any prize, including, but not limited to: (a) unauthorized human intervention in the Promotion; (b) technical or printing errors; (c) lost, late, postage-due, misdirected or undeliverable mail or email; (d) errors in the administration of the Promotion or the processing of entries; or (e) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from participation in the Promotion or receipt or use of any prize. Participant further agrees that in any cause of action, the released parties' liability will be limited to the cost associated with entering and participating in the Promotion, and in no event shall the released parties be liable for reasonable attorneys' fees.
- 11. <u>Disputes</u>. Except where prohibited, Participant agrees that any and all disputes, claims and causes of action arising out of the Promotion or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in the State of Illinois, U.S.A.. All issues and questions concerning these official rules, Participant's rights and obligations, or Sponsor's rights and obligations shall be governed by the laws of the State of Illinois, without giving effect to any choice of law or conflict of law rules. Some jurisdictions do not allow for limitations on the ability to pursue class action remedies, and so these limitations may not apply.
